Please remit ₹ 96,000/= (Rupees ninety six thousand) only as the **first installment** so as to reach here positively by **20<sup>th</sup> February, 2018** to ensure your ward's seat at the Vidyapith. However, the amount is non-refundable, in case the boy does not join after the payment of the initial money. The second balance installment of ₹ 35,000/= (Rupees thirty five thousand) only has to be paid by **17<sup>th</sup> June, 2018**.

All remittances should be made by any of the following modes:

- **Demand Draft** in favour of "**Ramakrishna Mission Vidyapith**" on any bank payable at **Deoghar, Jharkhand (not Deogarh of Orissa)**.
- By **POWER JYOTI** A/c of any SBI branch with the prescribed PAY-IN-SLIP (supplied by us). **The scanned / photocopy of the same must be sent to us through email immediately.** Please send us the original "**Institution copy**" by post / hand.

The above may be sent to Vidyapith through registered post or by hand within office hours, viz. **9.00 am to 11.50 am and 2.00 pm to 4.00 pm**.

Photocopy of selection letter for admission must be attached with the Demand Draft. Cheque, NET Transfer and Credit Card are **not accepted**. Draft sent by post must have a covering letter mentioning the Ward's Name, Class, Roll Number. Your ward will be given a Registration Number at the time of admission. **Do not forget to mention the Registration Number in all your correspondence hereafter.**

Expenditure for Exhibition, Picnic cum Excursion, Saraswati Puja Subscription and Travelling are adjusted against **Boys' Personal Deposit**. **Please note that in case your ward's personal expenses exceed the Personal Deposit amount, you will have to pay the extra amount.** Also you will have to pay any other extra fees/fine which might be necessitated due to other circumstances.
